2019 Email Connect and Win Contest

3. DEADLINES

The contest period begins on July 29, 2019 at 12:00 am and ends on September 7, 2019 at 11:59 pm, and the draw will take place on September 20, 2019.

The prize is not transferable and must be accepted as awarded with no substitutions. A member or non-member can apply and win the contest however picture ID needs to be disclosed when collecting the prize.
