

PROSPERA CREDIT UNION 2020 CREDIT UNION DAY CONTEST

Participation in the 2020 Credit Union Day Contest constitutes the entrant's full and unconditional agreement with and acceptance of these Official Rules and all decisions of Prospera Credit Union, which are final on all matters relating to the Contest.

1. ELIGIBILITY

Entrants must be legal residents of British Columbia who have reached the age of majority. Employees of the Sponsor, its affiliates, parent and sister companies, advertising and promotional agencies, contractors, distributors, and corporate partners and members of the immediate families of each are not eligible. All provincial, municipal and federal laws and regulations apply.

2. HOW TO ENTER

Prospera members will automatically be entered into the 2020 Credit Union Day Contest if they:

1. Are a current member of Prospera Credit Union (also formerly known as of Westminster Savings Credit Union).
2. Complete and submit the form on SurveyMonkey (<https://www.surveymonkey.com/r/MDXRGLF>).

No purchase necessary.

3. DEADLINES

The contest begins at 12:00 A.M. on October 15, 2020 and ends at 11:59 P.M. on October 29, 2020. The draw will take place on October 30, 2020, and the winner will be contacted by email no later than November 2, 2020.

4. PRIZE

There are three prizes of \$100 Amazon Canada gift cards available to be won. The prizes are not transferable and must be accepted as awarded with no substitutions. A member can apply and win the contest, however picture ID needs to be disclosed when collecting the prize. Sponsor reserves the right to substitute an alternate prize of equivalent or greater value if a prize cannot be awarded as described. Prize will only be delivered to the verified winner. All decisions of the contest judging organization are final and binding in all matters relating to this contest.

Entrants who have not complied with these Official Rules are subject to disqualification.

5. DECLARING A WINNER

There will only be three winners for this contest. Before being declared a winner, the selected entrant will be required to execute and return the contest sponsors' affidavit of eligibility and publicity/liability release within 14 days of receipt. If a selected entrant cannot be contacted, is ineligible, fails to claim a prize or fails to return a completed and executed affidavit and release as required, or is otherwise unwilling or unable to comply with these rules, that entrant will be disqualified. By accepting a prize, the winner consents to the use of their name and likeness for publicity and commercial purposes without further compensation.
