

2023 Annual General Meeting (Virtual AGM) - FAQs

1. Why is the 2023 AGM virtual?

Prospera's AGM is being held virtually to be inclusive of all members regardless of their geographical location. By hosting the meeting online, all members have an equal opportunity to engage with Prospera's leadership and decision-making process. This provides convenience, cost-effectiveness, and increased participation for members who can attend the meeting from their own homes.

2. Can I ask questions during the AGM?

Yes, you can! Questions can be submitted electronically throughout the meeting. Questions will be addressed in the order that they are received during the question period that will be held at the end of the presentation.

3. Why aren't members permitted to ask questions verbally?

With over 120,000 members invited to the webinar, the potential volume of questions could potentially be unmanageable. In order to make the webcast as efficient as possible, all questions will be received electronically.

4. Where can I get a copy of the 2022 audited financial statements?

You can find a digital copy of the 2022 audited financial statements, together with the 2022 annual reports, at 2022 Annual Reports | Prospera Credit Union. The corporate reports are also available at prospera.ca in the corporate reports section.

5. What time does the AGM start?

The AGM starts at 6:30 pm. However, you can begin logging in as early as 6 pm.

6. How do I access the virtual AGM?

You must first register at prospera2023agm.com. Once registered, you will receive a confirmation email on April 26, 2023, that contains your login credentials, voting access (if an eligible voting member) and link to the AGM.

7. When can I register for the AGM?

Registration is now open! Members can pre-register for the AGM until 5 pm on April 20th. Registration can be completed at prospera2023agm.com.

8. What is a Designation of Authorized Representative, and when do I need to complete it?

If you are a business, corporation, partnership or other entity, you must complete a Designation of Authorized Representative, when you pre-register for the AGM, to designate someone to vote on behalf of the entity. You are required to complete the designation if your



entity is voting on motions during the AGM.

Once the designation has been completed and signed (electronic signatures are valid) by the signing authorities of the business, corporation, partnership or other entity on file with Prospera, the designation must be emailed to **ProsperaAgm@prospera.ca**. If the entity does not complete and return a copy of the designation to **ProsperaAgm@prospera.ca** prior to the registration deadline of 5 pm on April 20, the entity will not be provided access to vote during the AGM.

You can complete the designation form at the time of registering for the AGM by downloading the designation form at prospera2023agm.com, completing, signing, and returning it by email to **ProsperaAGM@prospera.ca**.

9. What browser should I use to access the AGM?

To connect, we recommend using Microsoft Edge, Google Chrome, or Mozilla Firefox. For the best viewing experience, please ensure that you have the latest browser update on your device. We recommend testing your technology in the 30-minute window before the meeting begins.

10. What if I have technical issues during the AGM?

Your meeting experience may be affected by the speed of your internet connection, the age of your device, and other factors. Due to these individual circumstances, we are unfortunately unable to offer individual technical assistance and apologize if you are unable to connect to the meeting. We recommend testing your technology in the 30-minute window before the meeting begins.
