

## **2026 BC Lions Season Tickets Line of Credit Promotion Terms and Conditions**

The following terms and conditions govern the 2026 BC Lions Season Tickets Line of Credit Promotion offered by Coast Capital Savings Federal Credit Union (o/a “**Prospera**”) to assist its members with the purchase and financing of their BC Lions season (the “**Offer**”):

### **1. The Offer:**

The Offer period begins January 1, 2026 and ends on December 31, 2026 (the “Offer Period”).

Subject to the eligibility requirements and terms and conditions described below, eligible Prospera members who purchase BC Lions season tickets and successfully apply, qualify for, and are approved for a Line of Credit (the “LOC”) during the Offer Period will receive a 6-month interest-free promotional period on the outstanding balance of their LOC.

The LOC is intended to provide flexible financing for the purchase of eligible BC Lions season tickets.

Eligible LOC holders may qualify for additional 6-month interest-free promotional periods for future BC Lions season ticket purchases by providing satisfactory proof of purchase for subsequent football seasons, subject to Prospera approval and the terms and conditions in effect at that time.

### **2. Conditions and Eligibility:**

To be eligible for the Offer, you must:

- (a) Be a member of Prospera in good standing, who is a legal resident of British Columbia and at least 19 years old during the Offer Period.
  
- (b) Apply for, qualify for and receive approval from Prospera to open a new LOC account of up to \$10,000 during the Offer Period. Approval is subject to Prospera’s lending criteria and the execution of all required loan documentation and agreements.

- (c) Purchase one or more eligible BC Lions season tickets for the applicable football season directly from the BC Lions or Canadian Football League, or their authorized distributor
- (d) Provide valid and satisfactory proof of purchase to a Prospera representative assisting with your LOC application.

By participating in the Offer, you acknowledge that you have read, understood, and agree to be bound by these terms and conditions. Failure to comply with any of these terms and conditions may result in disqualification from the Offer, as determined by Prospera in its sole discretion.

### 3. Payment:

- (a) **6-Month Interest Free Period** – The 6-month interest-free promotional period begins at the time the LOC is funded. Interest will be charged on the LOC based on the outstanding balance and will be reimbursed by Prospera for the duration of the promotional period. Reimbursement may occur monthly or in another manner determined by Prospera in its sole discretion.

Following the end of the 6-month promotional period, the standard variable interest rate applicable to the LOC will apply to any outstanding balance.

Eligible members may qualify for additional 6-month interest-free promotional periods for future BC Lions season ticket purchases by submitting satisfactory proof of purchase for subsequent seasons, subject to Prospera approval and the applicable terms and conditions in effect at that time.

- (b) **\$100 Season Ticket Credit** – Eligible members who successfully obtain approval for a LOC and provide satisfactory proof of purchase of eligible BC Lions season tickets will receive a \$100 CAD credit.

The \$100 CAD credit is payable once per member per football season and is issued upon the first approved submission of eligible season ticket purchase using the LOC in that football season.

The \$100 CAD credit will not be issued for any additional eligible season ticket purchase submissions within the same football season under the same LOC.

Eligible members may qualify for a new \$100 CAD credit in a subsequent football season upon submission of new eligible season ticket purchase proof under the LOC, subject to approval and these terms and conditions.

The \$100 CAD credit will be deposited to the member's applicable Prospera account within a reasonable time following verification of eligibility.

- (c) **New Member Cash Offer** – Eligible new members may also qualify for Prospera's new member cash offer, subject to the applicable terms and conditions of that offer.

#### 4. Other Terms:

- (a) The Offer may be combined with eligible new member offers, unless otherwise stated by Prospera. The Offer cannot be combined with any other promotion, incentive, or offer not expressly permitted by Prospera. Prospera may change, extend, or withdraw the Offer at any time. Prospera may also disqualify anyone or revoke the Offer in respect of anyone whom Prospera reasonably believes is abusing, manipulating, or otherwise inappropriately benefiting from the Offer or engaging in criminal or dishonest activities in connection with the Offer.
- (b) The Offer is subject to all applicable federal, provincial, and municipal laws and regulations. Any dispute will be adjudicated by the courts sitting in Vancouver, British Columbia. The invalidity or unenforceability of any provision of these terms and conditions will not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these terms and conditions will otherwise remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not included.
- (c) All intellectual property, including but not limited to trademarks, logos, designs, promotional materials, web pages, source codes, images, drawings, illustrations, slogans, and representations are owned by Coast Capital Savings Federal Credit Union. All rights reserved. Unauthorized copying or use of any of Coast Capital Savings Federal Credit Union's intellectual property without the prior express written consent of Coast Capital Savings Federal Credit Union is strictly prohibited.
- (d) In the event of a conflict between any Offer details contained in these terms and conditions and any Offer details contained in Offer advertising materials, the details of the Offer as set out in these terms and conditions will govern.
