### This year, we're offering:

#### **Local Impact Grant (\$5,000 grants available)**

Two grants will be awarded to students who have demonstrated significant involvement in their communities, highlighting how this engagement shaped their personal growth and academic achievements.

#### **Future Leaders Grant (\$1,000 grants available)**

Fifteen grants will be awarded to students with both clear career goals and plans to positively impact their community's post-education, emphasizing forward-thinking and societal impact.

### To be eligible, applicants must meet the following:

- ❖ Be in attendance at a B.C. public post-secondary institution in Greater Vancouver, Fraser Valley, or the Okanagan in September 2026 (see the list of possible eligible institutions [here](#)).
- ❖ Provide their acceptance letter from a public post-secondary institution (if the applicant is currently in high school or is a mature student).
- ❖ Provide their transcript with a GPA of 3.0 or higher (if the applicant is a returning post-secondary student).
- ❖ Submit a complete and accurate application form with the above documentation on our [Do Some Good](#) application form.
- ❖ Family members of Prospera Credit Union employees are also eligible if they meet the above.

All applications will be accepted online through our partner's website, Do Some Good. This online process will ensure we receive your application in the fastest and most secure way possible. To get started:

#### Terms and conditions

All applications must meet the above eligibility criteria. Only applications received in accordance with the eligibility criteria will be reviewed and considered for a grant.

A minimum of one applicant will be chosen from each of Greater Vancouver, Fraser Valley and the Okanagan unless there are no eligible applicants in a given region.

Recipients will be chosen based on the eligibility criteria above and their answers to the questions on the application form.

All grant recipients are required to complete our Electronic Funds Transfer (EFT) authorization by email. No cheques will be issued.

Grants must be used for the sole purpose of funding the recipients' tuition expenses.

To comply with Canada Revenue Agency regulations, all grant recipients are required to submit their Social Insurance Number.

Grants will be paid out in the calendar year that they're awarded and can't be held over for future school years.

Prospera reserves the right to modify or revoke the grant program at any time. In addition, Prospera reserves the right to revoke a grant from a selected recipient for any reason, including if the selected recipient provided false, misleading, or inaccurate information to Prospera in connection with the application, or if the selected recipient did or does anything illegal, improper, or otherwise unbecoming of a Prospera grant recipient.

All applications will remain the property of Prospera.

The personal information collected in connection with the applications will be used and disclosed to consider, select, administer, and pay the grants, to report to the Canada Revenue Agency as required by law, and to publicize the names of the grant winners. Prospera may also collect additional information about the applicant through online searches, reference checks, and other reasonable investigations. All personal information will be governed by Prospera's [privacy policy](#).

Prospera uses one or more service providers (currently including Do Some Good Community Contribution Company Inc.) to collect and store all submissions throughout the length of the program for the above purposes.
